POETRY & PERFORMANCE ART

Three lyrics inspired by Sappho. New lyrics, based loosely on Sappho 16, Sappho 31, and Sappho 58, used by *The Roberto Rosenman Quartet* of Toronto on their album *Upstream* (released October 2015). The songs with my lyrics are entitled “Dance Again,” “Into a Dream,” and “Leaving me to be Blue.”

The Plains of Abraham. A 20-70 minute piece of performative epic poetry. This project represents my attempt to revive the epic medium of Homer as a viable vehicle of (scriptless) performance art. The poem takes for its subject the Battle of the Plains of Abraham (1759), within a larger cycle of material about the Seven Years War in North America. The poem has toured Canada on two occasions, in the Summer of 2000 and in the Spring of 2005 (with extensive sponsorship from The Dominion Institute). On the 2005 Tour the total audience for the poem surpassed 1600 listeners, and the Tour was widely covered in the Canadian media. The list of non-Tour invited performances includes shows at the University of Toronto, the Classical Association of New England, Dalhousie University, Acadia University, and Vassar College. Ongoing Verse Translation. Translations into heroic couplets of Juvenal’s *Satires* and Propertius’ *Elegies*. Unpublished, but in continuous development; so far I have completed *Satires* 1, 2, and 3 and half of *Satire* 4, as well as *elegies* 1, 2, 3, and 4. The object of this project is to demonstrate the effectiveness of the (much-maligned) heroic couplet in modern English. In renewing Juvenal in this manner, I am in fact joining a tradition which begun by Stapylton (1644) and continued by, among others, Holyday (1674), Dryden & co. (1692), Owen (1785), Gifford (1802), Marsh (1804), Hodgson (1807), and Badham (1831), all of whom translated Juvenal into heroic couplets. The traditionality of the endeavor fits with my interest in intertextuality and the theory of translation. In the case of Propertius, my object is to achieve a line-by-line correspondence with the original. The results can be seen on the web at www.jackmitchell.ca > Translations.
